The project, having a total investment value of about 1500 millions €, includes full conversion Hydrocracker, Steam Reformer, Sulphur recovery and Ancillary units in Sines refinery and Vacuum, Visbreaker and Ancillary units in Porto.

Responsible for refineries development, refinery performance optimization, refinery automation and refinery information systems.
